# **Finance Council Report**

These are the activities of the Finance Council since the beginning of 2022.

- 1. Quarterly meetings (at least) to review finance and the financial reports to date (balance sheet and profit/loss).
- 2. The Finance Council takes on the responsibilities of a building and grounds committee.
- 3. Since the beginning of 2022, Father Jim has directly managed finances because of the inability to find a qualified bookkeeper for the parish since only a few hours per week are needed. Father Jim has experienced with QuickBooks which the parish uses for accounting. Two signatures are required for any cheque that is written.
- 4. The financial report for the Archdiocese is prepared by an external accountant. The accounting firm also handles some on-going items like payroll preparation, filing for the CRA etc.
- 5. There are three employees of the parish: Father Jim (administrator), Parish Secretary Nancy Diokno (9-10 hours a week), and Caretaker Teklesenbet (Tekle) Mebrahtu (full-time). Musicians and a person who does church linens are also paid.
- 6. The organization and contracting of major projects takes up a considerable amount of our meeting time.
  - These are the projects we have recently completed; and each of these projects are funded from the Building Fund and in part (50% matching grant) by an anonymous donor:
  - 6.1. 2022 Church ceiling, walls and doors project involved repairing wall and ceiling areas which had been damaged before the new roof was installed. The areas needed to be dried out. The church doors (front and north) were repaired and painted (\$38,000).
  - 6.2. 2022 Rectory Bathroom and flooring project involved upgrading the rectory apartment bathroom by installing a shower. Also removing the "popcorn" ceiling and painting. New vinyl flooring to replace very old carpeting in the rectory (\$34,000).
  - 6.3. 2022 Kitchen, dining room and entry renovations involved new counters and appliances to replace a kitchen dating from the 1950's/60's; new flooring in the first floor, painting and repairing walls in the first floor. Electrical and plumbing repairs needed to be done in the kitchen area also. Also, some blinds were installed in part of the first floor (\$37,000).

These are the projects we are now planning; and each of these projects should also be funded in part (50%) by an anonymous donor:

- 6.4. 2023 (contracted and projected completion in June 2023) Solar panels and energy project has been contracted and downpayment made for the solar panels. Installation is scheduled for June 2023. The project will provide for 100% of our electrical energy needs (\$110,000). The parish portion of the costs (approximately \$50k) will be funded from our savings. This will be off set in approximately 8.5 years by the amount we now take from savings to pay utilities.
- 6.5. 2024 (proposal being developed) Accessibility project involves coming up with a design which will allow for an enclosed access on the north entrance with a wheel chair/elevator type lift. No cost projections yet but there is major grants available through the federal government for non-profits to upgrade accessibility in older buildings.

# **Pastoral Report of the Pastoral Council**

## Service/Liturgical

- Charmaine Elash is serving as the new coordinator of liturgical ministries.
- Debbie O'Malley and Charmaine Elash volunteered to guide three young members of our parish, along with their parents, in confirmation and first communion preparation.
- Communion is brought to "shut-ins" but this needs to be developed more.
- With the technical assistance of Victor Diokno, the Saturday 5:10 PM Liturgy at Blessed Sacrament is streamed live on YouTube.

#### Social Activities

- We are developing coffee/social time after Masses with the hope for more in the coming months of warmer weather.
- Over the past year we have met and planned several social activities which have been very successful. A Saturday night at the Copper Kettle, Coffee after Mass in the garden and rectory, and a birthday party for Father Jim.
- In July our Knights of Columbus are organizing the Canada Day Mass for 2023 (details in KC report).
- There was a reception after the Confirmation/First Communion Mass.
- We have also returned to a Mothers Day tradition of giving flowers to moms which is always appreciated.

## **Church Decor**

- Our call for donations for flowers at Christmas and Easter was responded to generously. The
  displays were so pretty. Thank you to all who donated time and money to make this
  possible.
- We had summer pots planted with annuals and palms, near the entrance and sides grounds of the church. We also added some new trees that have been planted in remembrance of families through donations from the families.

# **Building Fund Projects**

Working with the Finance Council, we assisted with the various building fund projects to sustain the parish. A full report on those projects in the Finance Council report. As we go

forward, we should keep in mind the beauty of our historic church, the oldest Catholic church in Regina.

# **Knights of Columbus Santo Nino Council**

The Santo Nino Council is based at Blessed Sacrament Parish. Presently the Council has a total membership of 132. The Council takes pride on being an integral part of the Parish. For the past and current year Council has the following activities:

- This January 2023, the Council together with the Parish welcome the Icon of St. Joseph who is on its pilgrimage at the province of Saskatchewan. Council members, their spouses and some parishioners held a Prayer Service in honour of St. Joseph.
- The Council donated the proceeds of its fund raising (CFL Football Pool tickets) to the Parish in the amount of \$580.00 last Dec. 2022.
- Santo Nino Council continue its liturgical service to the Parish every 4th Sunday 10:00 am Mass.
- Also, Council sets up the Nativity 'Creche' at the Church yard during the Advent Season.
- After a 2 year hiatus because of the Pandemic, Santo Nino Council will spearhead the celebration of the Canada Day Mass this July 1, 2023 at 10:00 am. After the Mass the congregation will be invited for a coffee and danish in the residence and garden.
- During the summer months, Council members and their family members hold a summer BBQ at the park. Enjoying the warm summer weather and a fellowship gathering among Knights, with their friends and families.
- A tradition of celebrating Christ birth; the Council hold a regular Christmas Socials and supper, where members and families get together, enjoy food and games and thank God for the greatest gift, Christ the Lord.

# **Good Shepherd Community Report**

The Good Shepherd Community, based at Blessed Sacrament Church, for those who celebrate the Ge'ez Rite (Catholic eastern rite of Eritrea) with membership from our parish and parishes throughout the Archdiocese. Based on the mission it has, the organization has accomplished many tasks for its congregation. The Good Shepherd performs its work mostly by the board members elected by the members of the Good Shepherd.

In December 2022, according to the by-laws, the organization elected its board members to lead the congregation. The board members were elected to serve under 6 branches or departments. The departments and its members with their responsibilities are as follows:

• Spirituality (Mearg Zerea, Zemhret Okubes). The function of this department is to lead and teach the congregation so that members of the church will live under the umbrella of spirituality and God's way of life.

- Church Service (Zereslasie Keleta, Kebreab Medhin). These church service members coordinate the church activities and communicates with priest in Blessed Sacrament church.
- Reconciliation (Akberet Zere, Selus Teklu, Bahta Berhane). They reconcile congregation
  members in case if there is some issues or problems. In addition, they advice members with
  some psychological, trauma or failures in spirituality.
- Finance (Kebreab Medhin, Yonatan Yemane, Ftsum Welde). These members work in planning organizing, directing, and controlling the financial matters of the organization.
- Sponsorship (Tesfom Kelati, Zeresilasie Keleta). Sponsorship is a new branch of the organization, and two members are working with tasks related to it as a project. The by-law allows to have projects to support people who are in need of help, members of the community and refugees outside Canada.
- Choir (Yafiet Yemane, Furtuna Zerea). Members of this branch work to coordinate activities in relation to spiritual songs during church services and outside of it.

The new board members are also working to teach children catechism every Saturday in the afternoon at 6:00pm. We now have two teachers, Mearg Zerea, Rona Silus and Akberet Zere.

Another accomplishment in our community: some members of our congregation were able to get baptism and confirmation by the help of Blessed Sacrament Parish.

Finally, the community was able to invite a priest from Calgary to have confession and liturgy in Eritrean language in our anniversary Good Shepherd Purgation on the date May 20, 2023.

In the same board members prepared 30 spiritual questions from the bible to teach and strengthen spirituality for our congregation. Moreover, there were guests from Saskatoon to participate in the celebration. They participated in the competition. It was a great experience for the guests. The Good Shepherd congregation was concluded by promising better preparation for the coming year.

In the Parish Council Constitutions, it states:

Section 2: Nominating Committee for Parish Pastoral Council
